



## FOSTER AGREEMENT

By submitting this Foster Agreement, I agree that:

- ✿ I am at least 18 years of age.
- ✿ I understand that I am making a commitment to fostering until my foster dog/cat has received the necessary vetting/training to be deemed adoptable by Fur Love Haven (FLH) and an adoption is finalized. I will notify FLH, without delay, if I can no longer care for or keep my foster animal and will await the finding of a new foster home (generally 2-4 weeks). I agree that I will notify FLH of any behavioral problems that have occurred while fostering.
- ✿ I will provide an FLH representative access to all parts of my home and property for a home inspection before my application to foster is approved. If approved, I also agree to provide an FLH representative access to my home and property to check on my foster animal, at any time that I am in possession of my foster animal.
- ✿ I will care for this animal in a humane and responsible manner and to provide it with clean and appropriate shelter, food, water, exercise and companionship. This animal will be indoors and will not be chained/penned outside. The dog is not to ride loose in the bed of pickup trucks, convertibles or be left in a hot car.
- ✿ If I am fostering a dog, the dog must be walked using a martingale collar provided by FLH. I will not take my foster dog to an off-leash dog park. If there is no fenced yard, the dog will be taken outside on leash on a regular basis for exercise and elimination needs.
- ✿ A representative from the organization may visit the animal to ensure that it is well taken care of. If we find that the animal has been neglected or abused in any way or for any reason, we reserve the right to remove the animal from the premises. Attempts to remove the animal shall not constitute trespass at the property occupied by the animal.
- ✿ I am fostering this animal for FLH and that I do not have any right of ownership over my foster animal. I further agree that FLH's rights in and to my foster animal are superior to mine. I will immediately return any foster animal in my care to FLH at the request of its authorized representative at any time and for any reason.

- 🐾 I agree to transport my foster animal to designated veterinary offices and provide care as authorized by FLH. I will not arrange or pay for any elective veterinary care for my foster animal without the express consent of an authorized FLH representative.
- 🐾 I agree to facilitate meetings with and answer questions by potential adopters.
- 🐾 I will take all necessary precautions to prevent my foster animal from either impregnating another animal or becoming impregnated. In the event that happens, I will notify FLH immediately.
- 🐾 If I am planning to move at any time during the period when I am housing a foster animal, I agree to contact FLH prior to my move and provide FLH with my new contact information (address, phone number, or email address).
- 🐾 **HOLD HARMLESS/INDEMNIFICATION:** The animal's known background and medical history have been discussed with me. I understand that FLH has made no representation concerning the health, condition, training, behavior, or temperament of the animal.

Fur Love Haven (FLH) and its Officers, Board of Directors, Volunteers, Affiliated Entities and/or agents shall not be liable to adopter on any theory of legal liability including but not limited to the negligence of FLH (and its Officers, Board of Directors, Board of Directors, Volunteers and/or agents) for any injury, death or damage directly or indirectly caused by this animal. Adopter does hereby release FLH (and its Officers, Board of Directors, Volunteers and/or agents) from any and all liability, claims, suits, obligations, demands or causes of action, known or unknown, foreseen or unforeseen.

- 🐾 I will comply with all applicable local and state statutes governing control and custody of animals.
- 🐾 If FLH is forced to undertake legal action to enforce any provision of this agreement, I agree to indemnify FLH for all court costs and attorney fees connected with such an action.
- 🐾 I authorize Fur Love Haven (FLH) to contact:
  - 🐾 My veterinarian(s) to check the care provided to previously and/or current pets, and to check the spay/neuter history;
  - 🐾 My landlord to ensure that I have his/her/its permission to keep pets) on the premises; and
  - 🐾 My employer to confirm employment
- 🐾 I certify that all the statements made by me on the Foster Application are true and correct.
